The above table gives a list of prosecutions for offences under the Water Supply (Water Quality) Regulations and the Water Industry Act. The table needs to be interpreted with care because the results are largely reflecting a historical situation. As a result of the prosecutions, the

water companies involved have taken steps to improve their operations and, in some cases, it is now rare for there to be events occurring in their areas. Also, there are cases pending or investigations under way relating to companies which are not included on this list.
