**REQUEST FOR INFORMATION: Water quality in the Thames Water catchment area with further details to cover Croydon**

Thank you for your request for information of 24 November 2025 about water quality in the Thames Water catchment area with further details to cover Croydon. We have handled your request under (EIRs).

The EIRs apply to requests for environmental information, which is a broad category of information defined in regulation 2 of the EIRs. Public authorities are required to handle requests for environmental information under the EIRs. They give similar access rights to the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

*I wish a list of all chemicals approved/and refused by Secretaries of State over the past two decades. Additionally what chemicals have the Committee approve under the voluntary scheme.*

*Should be in public domain and free of charge from WRc. I have not been able to access those updated documents.*

The current list of approved products used in contact with drinking water is available on our website at [https://www.dwi.gov.uk/drinking-water-products/resources-for-water-companies/approved-considered-products/approved\\_products/](https://www.dwi.gov.uk/drinking-water-products/resources-for-water-companies/approved-considered-products/approved_products/). All approved chemicals are listed here in section A of the list. Approvals on this list have to seek reapproval every 5 years. Also approved for use in drinking water are the chemicals listed in Annex 2 which is a list of British Standards (BSEN) for chemicals used for the treatment of water. Any chemicals that have been revoked or have had any changes refused also appear on this interactive list. There are no chemicals approved under a "voluntary scheme".

We do not hold a list of approved and refused chemicals for the last 20 years as this is continually being updated.

The information is therefore exempt under regulation 12(4)(a) of the EIRs, which relates to information which is not held at the time when an applicant's request is received. Regulation 12(4)(a) is a qualified exception, which usually means that a public authority is

required to conduct a public interest test to determine whether or not information should be disclosed or withheld. However, the Information Commissioner's Office (ICO), which is the independent regulator for requests made under the EIRs, takes the view that a public interest test in cases where the information is not held would serve no useful purpose. Therefore, in line with the ICO's view, Defra has not conducted a public interest test in this case.

However, under our duty to advise and assist applicants in pursuance of regulation 9, we can confirm that we are not aware of such a list existing and therefore to the best of our knowledge it is not held by any other public body.

*My area of interest: THAMES WATER CATCHMENT AREA. FURTHER REFINED TO COVER CROYDON.*

*I also seek detailed evidential water quality reports for Croydon.*

*I need documentary evidence on unapproved chemicals used in Croydon TAP Water.*

*How many enforcements have been carried out against Croydon Council and Thames Water for dangerous tap water quality?*

We have no records of unapproved chemicals being used by Thames Water in any area of their supply, which includes the Croydon area. The information is therefore exempt under regulation 12(4)(a) of the EIRs (please see wording above).

Please note that Thames Water is the supplier of drinking water, not Croydon Council, therefore we would not issue any enforcements to local authorities.

*Does the DWI follow up on TAP water contamination and if so what are your outcomes in the Borough of Croydon?*

We hold the water suppliers (not local authorities) to account, and full details can be found in our annual reports (<https://www.dwi.gov.uk/what-we-do/annual-report/>).

*I recently asked Thames Water to supply their plastic hose manufacturer so I could request the micro plastic in Thames Water Tap Water.*

*Please advise micro plastic calibration to the tap in Croydon? I already have the asbestos cement calibration but please supply for the Croydon Area so we in Croydon can then compare and contrast?*

We do not hold this information as microplastics are not a regulatory parameter in Schedule 1 of the Water Quality (Water Supply) regulations 2016. The information is therefore exempt under regulation 12(4)(a) of the EIRs (please see wording above).

*I read quite a few of your reports.*

*You stick to the tried and tested, coatings etc but nothing on ever growing commercial waste EG from fast fashion chemicals dumped in tap water in Croydon.*

*Nothing on contaminated water disease and death tolls.*

*I fully understand 'Mapping the Underworld' so do not need general information. What I seek is specific information regarding Thames Water and Croydon Council maladministration regarding water quality at least since 2013.*
